2. The invitation to tender states that we need to provide a tender security of 100,000/= while the TDS and mandatory evaluation criteria requests for both bid bond and tender securing declaration form. Kindly let us know which one needs to be provided.

- A6 Bidder must Submit a Duly Filled, signed and stamped tender securing declaration form
- A14 Attach Original Bid bond of at least Kshs. 100,000 valid for a period of 180 days from date of tender opening

Clarification: "ALL Bidders will be required to submit a bid bond/tender security of KES 100,000.00. Requirement A6 will NOT be considered as mandatory, hence requirement A14 as indicated below MUST be met by ALL Bidders."

3. Kindly clarify if the below forms need to be filled:
- a) Price schedule templates for goods manufactured outside Kenya already imported, goods manufactured outside Kenya to be imported and goods manufactured in Kenya as there is another price schedule provided
 - b) Price and completion schedule-related services form
